It has been demonstrated that the environmental conditions at the enrolled site have met the standards of the Iowa Land Recycling and Response Action Standards program in accordance with Iowa Department of Natural Resources (IDNR) rules in Chapter 137 of Iowa Administrative Code (IAC) 567 and Iowa Code Chapter 455H. Therefore, no further environmental response action is required at this site except as described below and subject to such changes in circumstances which could authorize reopening regulation of the site in accordance with Iowa Code Chapter 455H and IDNR rules:

### AFFECTED PROPERTY

The affected area includes the five properties located within the southwest quarter of the southwest quarter of the northeast quarter of Section 11, Township 83 North, Range 24 West in the city of Ames, Story County, Iowa.

This no further action certificate includes the following properties in Ames, Iowa:

- The Asgrow Seed Company property (approximately 4 acres), a vacant field adjacent to the east of the Garden Spot Realty.
- The Crane, Darrell, Revocable Trust property (approximately 1 acre), a vacant field adjacent to the northeast of the Garden Spot Realty property.
- The Garden Spot Realty property (approximately 9 acres) in the eastern and central portion of the affected area. This property consists of vacant land and was formerly occupied by a lumber storage building that was demolished in approximately 2003.
- The Meyer Family Investments, L.L.C., property (approximately 0.7 acre) in the northwest portion of the affected area, which includes a one-story tire service building. The building was formerly occupied by a roller skating rink.
- The Ward Development Company property (approximately 6 acres), in the southwestern portion of the site, which includes Excelerators go-kart track and a former Honda automobile dealership. This property was formerly occupied by Montgomery Ward, a grocery store and several other commercial/light manufacturing facilities.

The affected area is legally described in Exhibit 'A' of this document. The environmental assessment performed in the affected area is summarized in Exhibit 'B'. The contaminant of concern is arsenic as noted in Exhibit 'C'.

### NO FURTHER ACTION CERTIFICATE

Issuance of this no further action certificate provides certain legal protections and immunities to "protected parties" as defined in Iowa Code section 455H.103(11) and in accordance with Iowa Code Chapter 455H. Chapter 455H and IDNR rules also provide that under some conditions further response action may be required.

Elevated levels of soil contamination remain in the affected area and portions of the affected area may not have been assessed. Voluntary participation in the Land Recycling Program may in some cases not require the participants address all potential risks of exposure. IDNR records are available to the public and more fully describe the environmental conditions at the site.

This certificate does not constitute a warranty or a representation of any kind to any person as to the environmental condition, marketability or value of the above referenced property other than that certification required by Iowa Code section 455H.301 et seq. Interested parties should not rely solely on the representations contained in this no further action certificate.



### **Summary of Assessment**

In October 2005, Wal-Mart enrolled the properties in Iowa's Land Recycling Program (LRP) as described in Iowa Administrative Code (IAC) 567-Chapter 137 with the goal of obtaining a recordable "No Further Action" certificate from the Iowa Department of Natural Resources (IDNR) upon completion of response action at the site. Site assessment activities detected arsenic concentrations above statewide standards. Background sampling determined that the arsenic concentrations are consistent with natural occurring concentrations in soils.
