NO FURTHER ACTION CERTIFICATE

Mid American Energy Company Former Manufactured Gas Plant Site Charles City, Iowa

This document certifies that all or a portion of the properties described below has satisfied regulatory standards qualifying the affected area for a no further action classification under Iowa's Land Recycling Program in accordance with administrative rules contained in chapter 567 Iowa Administrative Code 137. A no further action classification generally means that voluntary participants in this program have identified and assessed specific contaminants of concern and sufficiently addressed them such that the risk to human health, safety and the environment is deemed acceptable according to standards adopted by the Iowa Department of Natural Resources.

A no further action classification applies to an area defined as the "affected area" which may or may not encompass the entire area of the parcels of real estate as legally described below. Exhibit A is a map of the area showing the MEC property and extent of off site groundwater contamination that was assessed and to which the No Further Action classification applies. Exhibit B is a narrative summary of the assessment of the affected area and regulatory history of the MEC property that has resulted in this no further action classification. Exhibit C, is a lists provided by the participant that identifies the known or suspected contamination. Exhibit D (table B-1) lists all properties within the affected area. The no further action classification applies only to certain contaminants of concern, as listed in exhibit C.

A no further action classification relieves "protected parties" from future environmental liabilities pursuant to Iowa Code Chapter 455H. The scope of the liability protection generally corresponds to the scope of the environmental condition(s) that qualifies for the no further action classification. Iowa Code section 455H.301 enumerates certain conditions that could authorize re-opening regulation of the affected area and removal of liability protections to certain protected parties. Interested parties should contact the Iowa Department of Natural Resources to obtain more information on the environmental conditions assessed within the "affected area" and any potential environmental concerns not specifically addressed or associated with areas outside the affected area.

The affected area includes the following parcels legally described as follows:

Mid American property in the Affected Area:

Block 138, Lots 29, 30, 31, 14 and the southern ½ of lots 13 and 32 in Lane's Addition to St. Charles now a part of the incorporated city of Charles City, Iowa.


Some residual soil contamination exists on the MEC property in excess of the preliminary remediation goals even after the (soil) removal action. In addition, there are other areas where soil was not excavated that were inaccessible during assessment due to buildings or other features that may have contaminated soil above the statewide standards. Contaminated groundwater exists on Mid American property and extends off the property to the southwest affecting the enrolled properties shown in **Exhibit A** and listed on **Exhibit D**. The extent of the groundwater contamination has been determined. The plume has been demonstrated to be stable and should decrease in concentration over time since all accessible contaminated soil has been removed. The contaminants of concern are volatile organic compounds, poly-nuclear aromatic hydrocarbons, metals and cyanide as listed in **Exhibit C**. **Exhibit E** shows the extent of the contaminated soil removed.

In 1994-94 a preliminary investigation was conducted that documented the presence of coal tar residuals in the soil and groundwater at this site. Soil borings were collected from different locations to delineate the extent of soil contamination and groundwater-monitoring wells were placed to document the extent of ground water contamination and direction of ground water flow.

In 1998, under the requirements of Iowa Consent Order 97-HC-03 approximately 2,660 tons of contaminated soil was removed under an Interim Removal Action and the excavated areas were back-filled with clean sand and topsoil (Exhibit E).

In January 2002 the MidAmerican Energy Company (MEC) enrolled the site into the Land Recycling Program that included a work plan describing the efforts that would be taken to complete the assessment and remediation of the site. In September 2002 MEC submitted a final site assessment report outlining past environmental efforts and stated goals for the eventual closure of the site. In October 2002 MEC submitted a Risk Evaluation/Response Action Report to document conditions and suggest remedies to address the contamination remaining at this site. The suggested remedial action was to restrict residential use of the MEC property, strengthen the local ordinance prohibiting private use of ground water in the affected area, and notifying local well permitting officials of the existing conditions. In addition, eight quarters of ground water monitoring have been completed and statistical modeling was conducted demonstrating the ground water plume to be stable and not expanding in extent.

In 2004 A 'Public Notice' describing the risk evaluation and recommended response actions remedies was published in the local newspaper. The public notice solicited comment from concerned individuals and resulted in a request for a public availability meting that was held in Charles City on May 10, 2004. Local concerns for public health and property values were addressed. The environmental protection easement restricting groundwater use and prohibiting residential land uses on the MEC property was implemented as prescribed in rule. Also, the pre-existing ordinance prohibiting the installation of private water wells within the city was strengthened to prevent installation of private wells within or near the off site affected area.

For a more in depth recounting of the details of site assessment, including the presentation of sample results for all contaminants, it is suggested that department files be consulted. In particular the "Final Report" dated March 7, 2004 contains an historical overview of the project.
