#### About the USER Site InformationReport

The USER Site Information Report is a compilation of the data entered by the Iowa Department of Natural Resources Uncontrolled Sites and Emergency Response staff. Sites are categorized by a unique identifier known as a Site ID. The number of USER sites entered into the database to date is 516

**Part 1** of the USER Site Report provides general information for a given site, such as the address, site name aliases, site background information, EPA and spill numbers, topographical map locaters, and site contacts. Also included in this segment of the report is site contamination information which identifies site contaminants detected in various media at the site, sources of the contaminants, source locations, and areas potentially impacted by the site.

Part 2 of the USER Site Report identifies regulatory activities taking place at a site. The status of those activities are also provided. The report is divided into four segments according to the regulatory activity: State Action, Assessment/Remedial Action, Consent and Administrative Orders, Record of Decisions, and Comprehensive Environmental Response, Compensation, and Liability Act (CERCLA)

**Part 3** of the USER Site Report is comprised of any work plans or site reports submitted to the IDNR. Information is provided on the number of work plans or reports associated with a site, when they were received by the IDNR, reviewed, responded to, and approved. Some reports are submitted for IDNR records and not necessarily for Department review.

**Part 4** of the USER Site Report is the status of a site if it is on the State Registry or has become a candidate for the Registry. Status information may include the eligibility of the site for the Registry, when it was added or removed from the Registry, and its site classification. The site classification is designated by the letters A through E, with "A" indicating immediate action is required at the site and "E" indicating no further action is required.

Site Background:

The facility has been in operation at the site since 1948. The company produces industrial and engine lubricants. The raw materials used are primarily hydrocarbon products and additives. The primary wastes are spent mineral spirits and carborated cleaning solvents (methylene chloride). Mineral spirits are petroleum distillates that fall between gasoline and diesel fuel in the refining process. The facility had five hazardous waste storage units which underwent RCRA closure in 1999. The hazardous waste storage units were removed from service in 1988 or 1989.

#### UNDERGROUND STORAGE TANK AND DUMPSTER AREA

Before October 1988, the operation consisted of transfering spent mineral spirits from the dumpster to the 10,000-gallon UST. The UST was installed in 1981. During October 1989, the UST was emptied and washed. The 440-gallon dumpster was washed in November 1988. In June 1989, the dumpster was painted and moved to concrete diked area where it was used to store waste oil until 1991.

#### OUTDOOR DRUM STORAGE AREA

This unpaved area was used to store up to 10 55-gallon drums of spent mineral spirits

#### INDOOR DRUM STORAGE AREA

This paved area was used to store up to 20 400-lb open top drums of spent mineral spirits mud.

#### WEST CARBORATOR CLEANER STORAGE AREA

The storage shed has a dirt floor. Up to 20 5-gallons buckets of spent carborator cleaner were stored on metal storage tray (120 gallon capacity) in this shed.

#### NORTH CARBORATOR CLEANER STORAGE AREA

This paved area was used to store up 10 55-gallons drums of spent carborator cleaner. The building was constructed in 1987.


