Tami, per our phone conversation yesterday, please see the test results from the University of Iowa Hygienic Lab for the mulch at the Cedar Valley Montessori School playground.

By way of background, this site was flooded back in June 2008, and was under 8' of water for three days. As a measure of precaution, we have removed the top 6" of mulch that was in direct contact with the flood water, and we had the remaining mulch tested. We intend to add 9" of new mulch to what remains at the site, but before we proceed, we wanted to be sure this strategy would be safe for the children at the school that may come in contact with the "old" material.

Please provide a risk assessment of the remaining mulch material and advise if any additional remediation efforts need to be undertaken by CVMS in order to render the playground safe for its intended activity.
