Frost Oil was founded in 1940 by Bernard Frost and began to distribute heating oil to Jesup, Iowa and surrounding communities.

In the 1960's, Frost Oil and Home Oil, both of Jesup, merged. Under the direction of Norb Bahl, the resulting company grew to be a large distributor of wholesale gasoline and diesel fuel, as well as continuing to supply the local area with fuel oil needs. During the same time, Frost Oil expanded further with entry into the propane business. Peter Reinertsen acquired Frost Oil in 1992 and continued an aggressive growth direction over the next decade.

In 1999 Consolidated Energy Co, LLC was formed. The founding members of CEC were:

Consolidated Energy Company was born of the desire of these parties to continue to grow the wholesale business, primarily through the Frost Oil network, and to combine our retail fuel and propane business into a strong entity that would compete effectively in the rapidly changing marketplace.

Consolidated Energy Co, LLC continued to grow by acquisitions as well. In 2000, Blue Line Oil of New Hampton, Iowa was acquired. Blue Line's operations fit well with our plans to grow our retail business. Also in 2000, CEC acquired Saunders Oil of Sioux City, IA. Saunders brought significant wholesale gallons to CEC, as well as additional brand relationships. Our most recent wholesale acquisition, in 2003, CEC acquired Pawnee Petroleum of Larned, KS. A strong regional business.

In 2006, Consolidated Energy purchased the Propane Operations of the Dunkerton Coop. The operation was a perfect fit for our retail market area and brought a significant number of gallons and solid customer base.

Also in 2006, Consolidated Energy added the LeMars, Iowa based Hentges Oil operation to our family. Hentges Oil's proximity to our Sioux City location and their solid business reputation and loyal propane and fuel customers have been a great addition to our business.
