Todd and Jennifer,

Todd and I recently discussed that it doesn't appear we've been notifying the current property owners or adjacent impacted property owners of the contamination related to the Thermogas sites. Since it's necessary to notify those impacted by the contamination, I would like to send letters to these particular parties to notify them of the site status and provide the link for them to view any site documents on the IDNR's online database. After sending this initial letter, I will copy these individuals on future correspondence so that they can stay informed.

I have attached a spreadsheet that I use to keep all the Thermogas sites straight. I have highlighted columns for the 'current property owner', 'current site usage', and 'current property owner contact'. I tried to fill out what information I could based on the report submittals and assessor's records but if you could fill in any of the missing details or correct anything that might be wrong, I would appreciate it. I assume you probably have all this information since you have to gain access to the properties for sampling.

There are a couple of sites that are impacting adjacent properties so I will need the contact information for these individuals as well. This includes the Algona site (location of MW-8), Emmetsburg site (location of MW-14 & MW-15), Marshalltown site (location of MW-9 and MW-11), and Washington site (location of MW-3, MW-8, MW-9, MW-13). I haven't seen the most recent reports for Dubuque or Marengo yet so I will wait to send letters to the interested parties until after I review these reports but I

would like the contact information for the adjacent residences west of the site in Dubuque and we should probably notify the adjacent property owner in Marengo (location of MW-5).

As discussed with Todd, the intent is not to raise any concerns but to simply provide notification that the Department probably should have done initially when the contamination was found and to include these individuals on future correspondence. Once I have the contact information, I will draft letters and provide them to you for comment before I send them.
