Dear Mr. Cook,

In support of the Army National Guard Munitions Response Site, Site Inspection effort, the Army has attempted to obtain rights of entry (ROEs) from the current property owners at 11 lowa munitions response sites. Rights of entry have been obtained for a majority of the sites, but due to a non-response refusal, the Army will not be able to complete fieldwork at one site. For two other sites we have adjusted the proposed fieldwork approach. Although the field team has mobilized out of lowa, they will return if the remaining ROE is obtained.

The issues at the three sites in question are summarized here and described in detail in the enclosures.

-NDNODS Ottumwa 500-yard Range. The ROE has not been received and, in accordance with our regulations, we are notifying your office that we are unable to conduct the site inspection on that property. We are seeking your assistance in gaining access in order to assess any potential risks related to munitions that may remain there. If we do not receive a signed ROE within 60 days of this notification, we will have to indefinitely suspend activities with regard to that property and redirect our resources to other work within the Army National Guard's Cleanup and Restoration Program. Please let us know of your intent to contact the property owner of the range. Please copy my office with any landowner communications so I may add them to our files.

-NDNODS Mount Pleasant Small Arms Range. A map depicting the alternative field work approach is enclosed, and upon concurrence from your department, change pages will be provided in the Final Historic Records Review/Work Plan.

-NDNODS Le Mars Small Arms Range. A visual survey transect has been proposed and a sample location has been relocated at the specific request of a parcel owner (Zachary D. and Jodi M. Sitzmann). A map depicting the revised field work approach at this site is enclosed.

# NDNODS Ottumwa 500-yard Range IAHQ-008-R-01

### No Fieldwork Explanation

Army is unable to obtain access to complete fieldwork on the former NDNODS Ottumwa 500-yard Range. Visual surveys and sampling can be conducted only on the parcels for which ROE access has been granted.

## **MRS Description**

The NDNODS Ottumwa 500-yard Range was identified as a single 18-acre MRS used by members of the Iowa ARNG for small arms training from 1887 to 1938. The MRS is currently privately owned by a single parcel owner and used primarily for agricultural purposes.

## NDNODS Mount Pleasant Small Arms Range IAHQ-006-R-01

## **Work Plan Change**

No visual surveys or sample locations are proposed in the SDZ area of the MRS where ROE refusals were received. ROE access was granted for parcels that comprise the former small arms range. The visual survey transects and sample locations were revised to focus only in the former small arms range area.

### **MRS Description**

The MRS was identified as a single 742-acre small arms range used by the Iowa ARNG for small arms training from 1964 to 1987. The range was reportedly built in approximately 1964 for small arms practice involving M14 and M16 rifles and .45 caliber pistols. The NDNODS Mount Pleasant Small Arms Range is currently owned by 18 private entities. No ROEs were requested from of these eight parcel owners because only a small portion of their parcels were within the MRS boundaries; Seven of the parcel owners approved the ROE requests; and four parcel owners refused ROE requests. Each of the four parcel owners listed below that refused ROE requests own parcels that are located outside of the former range area.


