RE: Notice of Change of Classification Registry of confirmed hazardous waste or hazardous substance disposal sites.

Dear Mr. Taylor,

Pursuant to Iowa Code section 455B.426, the director of the Department of Natural Resources was required to maintain a registry of confirmed abandoned or uncontrolled disposal sites located in Iowa. The director previously placed a property owned by Deere & Co. and located in Dubuque County, Iowa on the registry. The subject property is known as the John Deere Sanitary Landfill Site and is legally described as the following portion of lot 12:

The NE ¼ of the SW ¼, Section 27, T90N, R2E and the E ½ of the NW ¼ of the SW 1/4, section 27, T90N, R2E, and the N ½ of the SE ¼ of the SW ¼, Section 27, T90N, R2E and the NE ¼ of SW ¼ of the SW ¼, Section 27, T90N, R2E in Dubuque Township, Dubuque County, Iowa.

Pursuant to section 455B.427(3) of the Code of Iowa the director shall assess the relative priority of the need for action at each site to remedy environmental and health problems resulting from the presence of hazardous wastes or hazardous substances at the sites. In making assessments of relative priority, the director, shall place every site in one of the classifications listed at 455B.427(3)"a" through "e".

Pursuant to the requirements of section 455B.427(3) of the Code of Iowa the director has now reclassified the subject property. The above-described property in Dubuque County, Iowa is now-classified as:

"d." Site properly closed – requires continued management.

The site classification shall be revised for all subsequent annual reports and the registry of hazardous waste or hazardous substance disposal sites. Continued site management, as prescribed by the Department, is necessary at this property. This reclassification does not warrant to a future purchaser of the site that the site will be free from any future adverse impacts as a result of use of the site as a hazardous waste or hazardous substance disposal site.

Dear Recorder:

Iowa Code section 455B.426 provides that the director of the Department of Natural Resources shall maintain a registry of sites used for the disposal of hazardous wastes or hazardous substances. Pursuant to Iowa Code section 455B.431, the director shall file a statement with the county recorder disclosing the classification of the site.

A site in Dubuque County, known as the John Deere Landfill Site, has been reclassified. The department now finds that the site has been properly closed but requires continued management and can therefore be classified under section 455B.427, subsection 3, paragraph "d". This finding must be filed with the county recorder to be placed upon the property's title record.

Please find enclosed the Notice that is to be filed in the property records for this site. If there are filing fees, please submit a bill to the Department.
