Attached is the letter requiring additional remedial efforts we spoke of earlier today with a deadline of approximately December 30th for the submittal of a remedial action work plan, the paper copy will go out in the mail today. I know we spoke of trying to get the soil removed as soon as possible (before the ground freezes) but that might be too hard to accomplish with all the planning that needs to be done. So just keep the process going without having to pay for expedited services.

Also, as we spoke of, I will be contacting the land owner to complete an environmental assessment of the site to address the concerns of the possible legacy petroleum release.
