They can remediate it as stated in chapter 109.11(2), or directly bury it if the landfill permit allows it. I recommend they test TCLP for the 8 RCRA metals and for benzene prior to acceptance.

On July 23, 2021 I sent the following email to Susan Johnson with the Iowa DNR Solid Waste Section: Hi Susan,

I visited a site yesterday in Oskaloosa; the site of the Former Larry Clabaugh site now owned by Stephan Palen. The property is located at 1107 S 7th Street, Oskaloosa, IA 52577.

Larry Clabaugh had been putting vehicles, cars and trucks, at the site for possibly 20 years. These were primarily junk vehicles. Some of the vehicles leaked fluids on the ground while being stored on the property which likely included oil, fuel and antifreeze. The new property owner Stephan Palen is cleaning up the property and had a crusher come on-site to process the vehicles for scrap. They drained fluids from the vehicles and put them in large plastic totes. However, fuel and oil leaked on the ground as vehicles were moved around and crushed. I instructed the representative for the property owner (Lincoln Lynch) and an Environmental Consultant Dustan Smith with Environmental Edge, the contaminated soil would need to be excavated to sight and smell and properly disposed of.

The County Sanitarian Eric Dursky and I talked to Michael Farichild, the operator of the Mahaska County Sanitary Landfill about whether he could take petroleum contaminated soil at the landfill. Michael met us at the property and said he is permitted to take petroleum contaminated soil but the owner of the property would have to obtain a Special Waste Authorization which would likely include some type of sampling and laboratory analysis of the contaminated soil before it could be taken to the landfill.

I am contacting you about the Special Waste Authorization and sampling protocol that will be needed to see if the petroleum contaminated soil can be disposed of at the Oskaloosa Sanitary Landfill.

On Friday, July 22, 2021 I sent the following email to Lincoln Lynch and Dustan Smith explaining the clean-up standard for removal and disposal of petroleum contaminated soil at the site. The email read as follows: Lincoln and Dustan,

Thanks for meeting with us yesterday at the property at 1107 S 7th Street in Oskaloosa. On the east side of the property off of South 7th Street, during the process of cleaning up the property, removing and crushing junk vehicles some oil, fuel and possibly antifreeze was spilled on the ground surface even though fluids were collected from the vehicles before they were crushed. There were also several areas on the north side of the property and the back of the property (west side) where fluids leaked onto the ground surface while vehicles had been sitting.

Clean up of the petroleum contaminated soil will involve excavating the affected (contaminated) soil to the standard of sight and smell. This means removing the contaminated soil down to where you find fresh/uncontaminated soil.

I contacted Susan Johnson with the Iowa DNR Solid Waste Section. Susan issues special waste authorizations. We are hoping you can dispose of the petroleum contaminated soil at the Mahaska County Sanitary Landfill and a special waste authorization (issued by the Iowa DNR) will be needed. This will require sampling and laboratory analysis of a soil sample or samples per Susan Johnson's instructions as to the number of samples and what parameters will be required.

Lincoln thought the clean up could be completed by September 1, 2021.

On Friday, September 22, 2021 I sent an email to Susan Johnson with the lowa DNR Solid Waste Section explaining the situation, the need for the special waste authorization and asking her what parameters they needed to have soil samples analyzed for.

Thursday, July 22, 2021 continued:

Lincoln Lynch arrived at 1:00 PM and we walked the property showing him the areas where we found contaminated soil. In the front (east side) much of that area was affected and on the north and west sides of the property there were spots where fluids had leaked from vehicles when they had been sitting on the ground that needed to be cleaned up. I instructed Lincoln the contaminated soil would need to be excavated to sight and smell and hopefully it could be disposed of at the Mahaska County Sanitary Landfill.

Lincoln Lynch explained he was managing the clean-up of the property for the owner Stephan Palen. While we were there a consultant working for Enviornmental Edge arrived. He had been retained to collect asbestos samples from the buildings because they were going to be demolished. We filled him in on the situation with the contaminated soil and he said he could collect soil samples once we received information from Susan Johnson as to the parameters that needed to be analyzed to obtain the special waste authorization. Lincoln Lynch believed they could complete clean up of the contaminated soul by September 1, 2021.

We contacted Mike Fairchild the landfill operator for the Mahaska County Sanitary Landfill to find out if they could take petroleum contaminated soil at the landfill. He agreed to meet us at the site on S 7th Street. We met Mike at the site and he said the landfill had it in their permit to use petroleum contaminated soil for daily cover but the people disposing of the soil would need a special waste authorization which would likely include some sampling and laboratory analysis of the soil. Susan Johnson with lowa DNR issues the special waste authorizations and I agreed to find out from Susan what would be needed.

On Thursday, July 22, 2021 I went to the site with the Mahaska County Sanitarian, Eric Dursky. There was no one on-site (no one removing or crushing vehicles). Most of the vehicles were gone and we could see where they had moved vehicles to a crusher (large area with oil-dry applied). There were two large plastic totes containing fluids next to the building. There was a strong oil-fuel odor and we could see where oil-fuel had been spilled on the ground surface in the area just off South 7th Street (east side of property). We walked around the north side of the buildings and property in the back (west side of property). We found several spots where vehicles had been sitting and oil or other vehicle fluids leaked onto the ground. We went to the former Larry Clabaugh property at 1107 S 11th Street. We met two people working in the building and they called Lincoln Lynch who was in charge of the property clean-up. I spoke to Mr. Lynch and he agreed to meet us at approximately 1:00 PM at the property on S 7th Street.
