This letter acknowledges receipt by the U.S. Environmental Protection Agency, Region 7, of the following Safety-Kleen Systems, Inc.'s Resource Conservation and Recovery Act financial assurance document for the referenced Safety-Kleen Systems, Inc. facilities in Iowa:

Original signed Certificates of Insurance for Closure and/or Post Closure that show the facilities' costs for closure care provided under insurance policy CPE E601041 01 with the Great American Insurance Company, policy period is 7/31/21 – 7/31/2022, submitted to the EPA on January 12, 2022. The face amount of the policy is \$360,101 and covers the closure costs for both facilities. One Certificate covers the closure cost estimate of \$237,725 for the Des Moines facility; one Certificate covers the closure cost estimate of \$122,376 for the Davenport facility.

Safety-Kleen submitted the referenced financial assurance documentation in accordance with Title 40 Code of Federal Regulations Part 264 Subpart H – Financial Requirements and in accordance with each facility's RCRA Hazardous Waste Operating Permit. The EPA's review of the Certificates shows the revised closure cost estimates for the two referenced facilities are the EPA-approved closure cost estimates. Each revised closure cost estimate is properly reflected in the referenced financial assurance documentation.

Please note that Safety Kleen, Systems, Inc, is responsible for maintaining compliance with each referenced facility's RCRA Permit and all hazardous waste regulations.
