Iowa Land Recycling Program and Response Action Standards

Lake Mills, Winnebago County, Iowa The Iowa Department of Natural Resources (IDNR) has been monitoring environmental assessment and remedial activities under the Iowa Land Recycling Program (LRP) for the former Cummins Filtration site located at 311 North Park

Street in Lake Mills, Iowa, hereinafter referenced as the 'site'.

Although the site is currently owned by Cummins, and is occupied by an agriculture parts manufacturer, known historic uses include filter manufacturing and cannery operations beginning in 1893. The area around the site includes a railroad, industrial, and residential land.

Environmental assessments at the site identified and delineated chlorinated volatile organic compounds (VOCs), naphthalene, 1,2,4-Trimethylbenzene, and 1,3,5-Trimethylbenzene in shallow groundwater at concentrations in excess of IDNR Statewide groundwater standards. Limited vertical migration below the shallow groundwater zone appears to have been delineated. VOCs were also documented in soil gas and indoor air samples collected from the site. There are also ome limited occurrences of Polycyclic Aromatic Hydrocarbons in soil exceeding IDNR statewide standard for soil beneath the building.

Exposure pathways deemed complete or potentially complete at the site include: i) exposure to or ingestion of dust from soil; ii) groundwater ingestion; and iii) vapor intrusion. The site is currently zoned industrial and prohibition of residential land use by an environmental covenant is planned for the site.

The following response actions are proposed: Soil: An environmental covenant prohibiting residential land use will be executed and recorded for the site to eliminate this exposure pathway. Analytical data obtained during the site assessment were used to evaluate both the cancer and non-cancer risk for Site Worker and Construction Worker exposure scenarios and were found to be acceptable using the LRP Cumulative Risk Calculator.

Groundwater: An environmental covenant restricting groundwater usage on site will be executed and recorded for the site to eliminate this exposure pathway As part of verification of the applicability and effectiveness of this response action, two years of quarterly groundwater monitoring was initiated in 2019 to demonstrate the stable to shrinking nature of the contaminant plume.

Soil Gas/Vapor Intrusion: A sub-slab depressurization system (SSDS) was installed beneath the onsite building. The SSDS is operated in accordance with an Operation and Maintenance Plan that will be recorded in an environmental covenant and kept onsite for easy access. These actions mitigate risks associated with this exposure pathway.

Upon successful implementation of the response actions, and reporting of favorable results from the verification sampling, IDNR will issue a 'No Further Action' certificate for the site.


