This letter provides an annual accounting of remedial action financial activities for the PCE Former Dry Cleaner Site A72Q. In addition, this letter serves as a request for payment of the 10% State cost-share requirement pursuant to Superfund State Contracts (SSC) 21-01-IA-A72Q-01.

We have prepared the following table showing a breakout of remedial action financial activity between the Superfund Trust Fund and Superfund Special Account through the period ending December 31, 2021. Only specific appropriated Superfund expenditures are billable to the state and included in the state's cost share. Special account expenditures are not cost shareable by the state.

As the table shows, EPA has expended Superfund Trust funds in the amount of \$24,427.47 for remedial action at the site, resulting in a 10% State cost-share of \$2,442.75. Special Account funds totaling \$0.00 have also been expended at this site through December 31, 2021.

EPA has received cost-share payments in the amount of \$0.00 and credits in the amount of \$0.00 resulting in an overall balance due of \$2,442.75. The EPA hereby requests payment in the amount of \$2,442.75. The non-ARRA State cost-share current balance due is payable 90 days after

receipt of the EPA's annual accounting of the remedial action costs incurred or whenever State appropriated funds become available to make such payments if funding is not immediately available.
