Shelly – This email will serve as a follow-up for the installation of a concrete ramp leading from the parking lot on the north side of the building for the movement of material at our Osceola Body Plant. The scope of work was outlined in the letter sent to Mike Sullivan on 21 September 2023 (Binder1.pdf attached). The excavation of the old concrete and some soil was conducted on 26 September 2023. Excavated material was separated into two piles- one for the excavated concrete and one for the excavated soils. Excavated materials were placed on plastic tarps and the covered with additional plastic tarps to prevent rainwater and wind contact. The tarps were secured to prevent them from being blown away. Concrete was poured for the new ramp on 27-28 September 2023.

Photographs of the project are included in the attached PowerPoint file.

On 3 October 2023 a representative of One Environmental Group visited the Osceola Body Plant to conduct representative sampling of the piles with the purpose of profiling the excavated materials for disposal at an offsite licensed facility. A copy of the report including the sampling protocol and laboratory analysis is attached.

Based on the results of the stockpile sampling the excavated material would be considered nonhazardous waste. It is Altec Industries' intention to send the excavated materials to:

I would appreciate if you could review of the information provided and get back to me with approval to proceed with the disposal of the excavated material as soon as possible.
