#### CLARIFICATIONS:

- 1. The contractor is allowed to do any shaping of the lake bed to accommodate the haul route. This includes cutting into the bank to form a road. Restoration of the lakebed is not required, unless the resulting slope is steeper than 3H:1V. Due to long-term stability concerns, any constructed slopes steeper than 3H:1V will need to be flattened. All other grading activities do not need to be restored to pre-construction conditions.
- 2. Fabric or geowebbing for the haul road that is covered by a granular surface may remain in the lakebed.
- 3. To clarify questions associated with bid item #2, Class 10 Excavation (Sediment Removal) and specification Section 01250 Measurement and Basis of Payment, Part 1.03 and 1.04, it is the intention of the plans to remove 200,000 CY of material from the upper end of the lake. Field adjustments, at the discretion of the Engineer, can be made if isolated soils within the sediment removal limits are impractical to be removed. Excessively wet areas may be traded for deeper cuts in order to achieve the 200,000 CY goal of the project. Cut material from within the sediment removal limits used as fill for jetties and fish habitat structures will be counted towards bid item #2 and bid item #3, Class 10 Excavation (Embankment Fill).

      - Jetty and habitat fill operations may occur during frozen conditions – overbuild will be required, depending on conditions.
      - Measured by pre- and post-construction survey

- Extent and location of removed material may be field adjusted but total quantity will attempt to be held consistent
- Haul road
  - Contractor is responsible to construct and maintain as necessary – This includes temporary culverts, channelization, crane mats, etc.
  - o Entire lake bottom is available to use
  - Crushed concrete, rock, or built up soil do not need to be removed from below the waterline

## Spoil Site

- Located west of dam
- Minor tree clearing along the top of the ridge is allowed if necessary
- 15' max. height, 4:1 side slopes

# **§** Shoreline Armoring

- 5 locations
- Rock hauling on in-lake road only
- Traffic Control
  - Pavement replacement is to occur before hauling over road
  - o Single lane on dam limited to 550 feet

#### Utilities

- § Abandoned sewer line is anticipated to be below cut
- **§** Contractor responsible for one call verification
- § No temporary power is available at county road crossing
- Road closures
  - **§** Pavement replacement is to occur before hauling over road.
