## **Clarifications:**

- Contractor is not required to install a cofferdam and dewater the area around the pipe on the lake side.
   Contractor must satisfactorily plug and grout the pipe solid as outlined in the plans but the method in which they do so will not be dictated by the Iowa DNR; the method to achieve solid grouting shall be determined by the contractor. Contractor shall confirm, with any method they determine to use, the pipe section that remains is completely filled with the grout outlined in the plans.
  - a. Regarding the pipe valve, it is the DNR's intent to have this removed from the pipe run, the contractor may cut the valve out and leave the valve in the vault.
- 2. Two-component, hydrophilic, underwater epoxy shall be used to seal the perimeter of the pipe on the lake side.
