### Comments:

On October 9, 2024, I visited the Edgewood Yard Waste site. A large amount of woody debris was observed piled. Minimal garden waste was observed. The area appeared well-maintained.

A few pieces of dimensional lumber were observed, but it appeared staff remove unacceptable material.

A lockable gate is provided to deter improper disposal at this site.

On October 25, 2024, I spoke with Mr. Pape by phone. He noted that the yard waste is ground annually. If there is a storm or similar event, they may grind twice a year. Yard waste is then screened and available for use. As the material received is approximately 85% wood waste they are unable to effectively compost and operate the site as more of a mulch processing area.

It was noted that there are potentially 7 residences located within 500 feet of this location. Mr. Pape indicated that this site has been here for many years and they've received no complaints. To comply with 567 IAC 105.3(1) the city should obtain written approval from residents within 500 feet and request

a department waiver to the 500-foot separation. If the city does not wish to pursue this option, the facility should be moved at least 500 feet from the nearest residence.

The signage indicates acceptable and unacceptable materials. However, 567 IAC 105.4(2) requires a site name, hours, and contact number to be included. The signage should be updated to include all required information.

## Requirements:

Compost operations must be 500 feet from the nearest residence. Either obtain written waivers from each resident within 500 feet and request a waiver from the department or move the composting operation to meet the 500 foot requirement per 567 IAC 105.3(1).

Obtain facility signage with all information required in 567 IAC 105.4(2).

Provide a written response by **November 27, 2024**, via email to amber.sauser@dnr.iowa.gov outlining how the above requirements are being addressed.

105.3(1) The composting facility shall be 500 feet from any existing inhabited residence, not including the residence of the person owning/operating the compost facility, at the time the permit application was received by the department. Composting must be done outside of wetlands, at least 200 feet from public wells, 100 feet from private wells, 50 feet from property lines, and 100 feet from flowing or intermittent streams, lakes, or ponds. Composting done inside the 100-year flood plain shall be in accordance with all local and department regulations including 567—71.5(455B). Sediment ponds, engineered wetlands or other constructed waterways for the purpose of pollution control are excluded from this requirement.

**105.4(2)** The facility shall have a permanent sign posted at the entrance specifying:

- a. Name of operation.
- b. Operating hours.
- c. Materials which are accepted or the statement "All materials must have prior approval."
- d. Telephone number of 24-hour emergency contact person.
