On July 27th I recieved a message via phone from the DNR field office. It stated ther was construction material dumped into yankee run creek, which goes through my property. On July 28th, I took my pickup down to my field and found a matted down section of grass along the creek and then saw a pile of ~~construction~~ construction debri. I didn't quite know what I should do about it, but as the land-owner of the ground, I knew it needed to be cleaned up. So I went back home and got a trailer and then drove back to the site and cleaned up all the waste. It was proly a pick-up load. I ~~throw~~ threw it all on my trailer and then took it to Clarence and put it in my dump trailer which was at a jobsite of mine. I shinge houses in the summer so ~~this~~ it was not a big deal to throw it in my dumpbox. Then ~~the~~ on 7/31/12 took the dumpbox to the cedar co. transfer station to get dumped. They noted the drywall and shingles on the ticket. As a result of this dumping I will put up ~~two~~ two posts at the access pt. of my field and dead lock a chain between the posts so no one except myself has access. This will hopefully take care of illegal dumping on my property.
