Dear Mr. Crawford:

At 3:30 pm on April 7, 2016, the Department of Natural Resources was notified of an approximate 5,000 gallon manure spill at the PI 261 Finisher confinement site located in the SE ¼ Section 27, Willow Township, Greene County. During manure application by Danner Custom Hauling, a manure spill occurred from the pump being used to pump manure from the below building pits. I conducted an investigation that day. A copy of this letter is also being sent to Danner Custom Hauling.

During the investigation, I observed manure pooled up on the property and in the roadside ditch. While a tile intake is located in the road side ditch, downgradient from the confinement, employees of Danner Custom Hauling dammed up portions of the ditch essentially diverting and containing the product in the ditch. No waters were impacted.

I required that all pooled up manure be pumped up and the impacted road ditch and shoulder of the road be excavated to site and smell. On April 11, 2016, I conducted a follow up inspection and determined that all manure had been properly removed and land applied. Photos of the investigation are attached to this letter.

Departmental Rule 567-131.2(455B) of the Iowa Administrative Code requires a written report to be submitted to this office within 30 days specifying the details of the incident. Attached you will find a reporting form that must be completed and returned to this office by **May 10, 2016**. Please submit a separate report documenting how you intend to prevent this type of an incident from occurring again.
