Administrative Order No. 2022-AFO-03 was issued to William Lawler and Jeff Lawler (Lawler) on February 1, 2022 and was timely appealed. Following discussions between the parties, and in the interest of settling the appeal, the order is amended as follows:

1. Paragraph 12, Section III STATEMENT OF FACTS is added as follows:  
  
On March 11, 2022, Lawler submitted a Plan of Action to ensure there is adequate storage and proper land application for all manure produced at the facility and the Plan of Action was accepted by DNR Field Office 1.
  
2. Section V ORDER is replaced with the following:
  1. Operate and maintain all animal feeding operation structures in compliance with all applicable DNR rules and regulations, including the regulations for manure storage, land application, and animal disposal;
  2. Pay fish restitution in the amount of \$22.06, Fisheries Bureau investigative costs in the amount of \$450.99, and Field Office investigative costs in the amount of \$665.33 for a total restitution and investigative costs of \$1,138.28 within 30 days of the date the Director signs this Consent Amendment to Administrative Order No. 2022-AFO-03; and
  3. Pay an administrative penalty in the amount of \$7,000.00 within 30 days of the date the Director signs this Consent Amendment to Administrative Order No. 2022-AFO-03.

4. The Paragraph 2, Section VI PENALTY is replaced with the following:

For purposes of settlement of the appeal of Administrative Order No. 2022-AFO-03, the parties have agreed that William Lawler and Jeff Lawler shall pay a penalty in the amount of \$7,000.00 within 30 days of the date the Director signs this Consent Amendment to Administrative Order No. 2022-AFO-03.

5. Section VII APPEAL RIGHTS is replaced with the following:

This Consent Amendment to Administrative Order No. 2022-AFO-03 is entered into knowingly and with the consent of William Lawler and Jeff Lawler. The Consent Amendment to Administrative Order No. 2022-AFO-03 resolves the appeal filed on February 15, 2022. William Lawler and Jeff Lawler waive their right to appeal this Consent Amendment to Administrative Order No. 2022-AFO-03.

6. In all other respects, Administrative Order No. 2022-AFO-03 remains in full force and effect.
