The Department and Sunrise Village LLC and Havenpark Management LLC d/b/a Sunrise Village MHC LLC and Sunrise Village Mobile Home (collectively referred to as Sunrise Village) have agreed to the below modification of Administrative Consent Order No. 2022-WW-28:

- 1. Section III statement of facts is amended to include the following:
- 13. Modern Manor Mobile Home Park is adjacent to Sunrise Village. Sunrise Village became the owner of Modern Manor in January of 2022. Modern Manor discharges wastewater pursuant to NPDES permit No. 5200605. Since October 2018, this facility has been out of compliance with its NPDES permit. The below chart contains all effluent violations from October1, 2018, through June 30, 2023.

- 2. Section V. Order paragraphs 1-3 are replaced with the following:
 - 1. By December 31, 2023, submit a report to the Department indicating whether Sunrise Village will either (1) connect to the City of Iowa City's sanitary sewer system or (2) upgrade its WWTF;
 - 2. By December 31, 2024, Sunrise Village shall either: (1) submit to the Department a progress report detailing the steps taken towards connecting to the City of Iowa City's sanitary sewer system or (2) a construction permit application for all necessary WWTF upgrades; and
 - 3. By December 31, 2025, Sunrise Village shall either: (1) complete the connection to the City of Iowa City's sanitary sewer system or (2) by November 30, 2026, Sunrise Village shall complete all necessary upgrades to its WWTF.
