Dear Mr. Conner,

The Department of Natural Resources (DNR) Solid Waste Section received the 2021 Annual Water Quality Report for the closed Wright County Landfill submitted on your behalf by Evora Consulting on October 12, 2021.

The report has been reviewed and is acceptable as received. Your consultant has recommended no changes to the monitoring plan for 2022 and beyond. The following changes are acceptable as noted below:

- Locations PZ-1B and PZ-2B can be removed from the annual hydraulic monitoring system plan (HMSP) based on generally insufficient water to ensure proper sampling, and the generally up-gradient nature of the locations. These two monitoring points should be maintained in operable condition should future groundwater gradient(s) indicate that groundwater may be leaving the site to the east.
- The biennial monitoring well maintenance and performance re-evaluation has been conducted using rules in effect at the time when the landfill was closed (IAC 567-113.21(2) enacted in 2002). Your consultant has recommended that henceforth, the site use procedures in the newer version of the rules (IAC 567-113.10(2)f.). DNR approves this change.

A permit amendment will be included with this letter noting the changes above.

The Hydraulic Monitoring System Plan is amended to the following until further notice:

- Monitoring groundwater at locations PZ-1B and PZ-2B is not required. These wells shall be maintained and operable until further notice.
- Biennial Monitoring Well Performance and Re-Evaluation Plan requirements may be amended to reflect procedures in IAC 567-113.10(2)f.
