Regarding the items which were outlined as needing correction:

117.6(2)"b" Site secured by a fence and signageSee attached email for additional fencing per Robert Sikes email.

117.6(2)"d" Signage:

See attached quote for additional signage per Robert Sikes email.

117.3(6)a; Quantity of whole tires on site; Reported volume at end of year indicated more than 750 tons of preprocessed tires on site.

End of calendar year 2021 semi-annual report shows more than 750 tons on whole tires on site caused by seasonal increased inbound volume of whole tires. Also, end of December 2021, Liberty Tire's Des Moines Iowa facility had an unexpected mechanical breakdown which delayed whole tire processing until repairs were made. The reported whole tire volumes are accurate as of 12/31/2021.

117.6(4)"a" Total volume stored on site:

Total processed volumes (finished and packaged goods commodities) do exceed 5,000 ton from time to time. The total tons are reported on semi-annual reports. These total tons include all finished and packaged goods/commodities stored on site and off site. The on-site finished goods tons on 12/31/21 did not exceed 5,000 ton.

Bottom of Inspection Report Comments:

All required outbound volumes, as requested by semi-annual activity report, are documented. All metal would include tire wire (delivered to Wilton, IA) and rim steel (delivered to various end markets). Manufacturing by-products are delivered to Liberty Tire, Savage MN facility for further processing or landfill disposal.
