A tract of land located in the SE ¼ of Section 22, Township 68 North, Range 42 West of the 5th P.M., Fremont County, Iowa, more fully described as follows: The SE ¼ SE ¼ of said Section 22; the North 330 feet of the East 660 feet of the SW ¼ SE ¼ of said Section 22; the S ¼ of the SW ¼ SE ¼ except the West 990 feet; the S ½ SE ¼ NW ¼ SE ¼; and the NE ¼ SE ¼ except that part North and East of the center of an existing creek, subject to all easements of record; excepting therefrom a tract of land located in the SW ¼ SE ¼ of Section 22, Township 68 North, Range 42 West of the 5th P.M., Fremont County, Iowa, more fully described as follows: Commencing at the S ¼ corner of said Section 22; thence N90°00'00"E along the South line of said SW ¼ SE ¼ a distance of 990.0 feet to the point of beginning; thence N1°04'20"E and parallel with the West line of said SW ¼ SE ¼ a distance of 500.09 feet; thence N90°00'00"E and parallel with the South line of said SW ¼ SE ¼ a distance of 164.88 feet; thence S0°00'00"W a distance of 500.00 feet to a point on the South line of said SW ¼ SE ¼; thence S90°00'00"W along the South line of said SW ¼ SE ¼ a distance of 174.24 feet to the point of beginning.
