1. Yes, some of the trees are on the cap along the former access road. I have discussed with Frank Frieberg, Director of Operations, and he has indicated that the trees will be removed by April 15, 2024. We will report on the status of the tree removal in our Spring semi-annual engineering inspection report.

2. Installation of passive gas venting has been discussed with IDNR staff previously and was referenced in the IDNR letter dated January 30, 2019 (Doc #94276).
