All –

I wanted to reach out to provide you with an update on leachate piezometer installation progress. Surveying is scheduled to be completed on March 3. A total of six piezometers with three potential locations within a 20' diameter for each will be staked. Drilling and piezometer installation is scheduled to be completed on March 6 & 7 after which a leachate level in each new piezometer will be measured. As discussed previously with the DNR, the installed depth of each piezometer will be approximately 5' above the clay liner. Please let me know if you have any questions or comments
