Apologies for the delay, I was out of the office earlier this week and am playing a little bit of catch up. Here are the answers to your questions below:

- 1. Checklist item 4.g.3. the wrong gradation was inadvertently referred to when filling out the checklist. The gradation requirements per the project specifications for the drainage media are listed correctly in checklist item 4.g.1. Both of these gradations have no more than 5% by weight passing a #200 sieve, and meet this requirement.
- 2. Confirmed, the CQA Plan is the same as the last cell. The pdf is attached here for quick reference.

Why is the percent fines greater (as shown in construction checklist) than 5% as required by 113.7(5)b.(7)3:
3. One of the following high hydraulic-conductivity materials: High hydraulic-conductivity material (e.g., gravel) of uniform size and a fines content of no more than 5 percent by weight passing a #200 sieve . The high hydraulic-conductivity material shall be at least 12 inches in depth and have a hydraulic conductivity of at least 1 × 10-2 cm/sec;
Also, Is the QA/QC plan the same as last cell? If not would you share with me?
