The closure of the Ottumwa Generating Station (OGS) Zero Liquid Discharge (ZLD) Pond has been conducted in accordance with the written Closure Plan for the Former OGS Zero Liquid Discharge Pond – Amendment No. 1, dated June 10, 2025.

As of the date of this letter, the closure of the OGS ZLD Pond has been completed to satisfy the requirements in 40 CFR 257.102. The closure has been completed by removal of coal combustion residuals (CCR), and groundwater corrective action will be completed during the post-closure care period in accordance with 40 CFR 257.102(c)(2).



- The memorandum issued by SCS Engineers on November 8, 2021, and provided to Alliant Energy, regarding CCR removal from the Zero Liquid Discharge Pond.
- The April 14, 2022, Construction Documentation Report, Zero Liquids Discharge Pond (ZLDP) Closure and Low Volume Wastewater Treatment Pond (LVWTP) Construction prepared by SCS Engineers and provided to Alliant Energy.
- The amended written closure plan dated June 10, 2025, prepared by SCS Engineers and provided to Alliant Energy for posting to Alliant Energy's CCR Rule Compliance Data and Information website.
- The letter dated June 10, 2025, prepared by SCS Engineers and provided to Alliant Energy, documenting that the requirements in 40 CFR 257.102(c)(2)(ii)(A) and (B) have been met, allowing Interstate Power and Light Company to complete groundwater corrective action for the former Zero Liquid Discharge Pond at the Ottumwa Generating Station during the post-closure care period.
