Good morning Chad,

Due to storms earlier this year in the permitted service area for the Bremer County Citizens Convenience Center (IDNR Permit No. 09-SDP-10-07P-CCC) the facility will exceed the 2,000 ton authorization in Special Provision X.1 for 2025 and most likely 2026. On behalf of Bremer County, we are requesting that the limit in Special Provision X.1 be increased from 2,000 tons to 5,000 tons for the duration of the current permit.
