Chad,

I emailed Frank Frieberg regarding the issues you and I had discussed, his answers are in red:

1. During temporary transfer station operations, where will commercial waste vehicles haul to? **Dubuque and Clinton landfills.**
2. What landfill will the waste collected at the temporary transfer station be hauled to? **MWI/Quad Cities Landfill, Milan IL.**
3. Timeline START - when would you like to start using the temporary transfer station? **Nov. 1 2025**
4. Timeline END - when do you think the transfer station rebuild will be complete and back in operation? **Jun1 2026?**
5. How much waste do you expect to receive at the temporary transfer station? Daily, weekly, or monthly, whatever is easiest for you. **100 tons a week?**
6. How will you estimate the tonnage of incoming loads? **Weight at scale at landfill. We know the trailers will not be carrying full loads.**
7. What recyclables do you plan to accept and where will they be stored? **Household hazardous waste-stored in HHW building. Tires stored in tractor shed. I don't think we will have enough room for appliances. We won't have a facility for waste oil. Electronics stored in tractor shed. Scrap metal in rolloff container.**

I hope this is the information you are needing to allow IDNR approval of the Temporary Emergency Transfer Station. Please let me know if you have any questions or need additional information,
