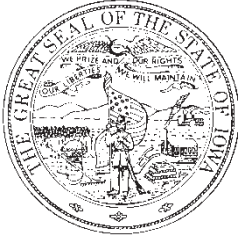

IX. General Provisions

1. The above-named permitted agency is hereby authorized to operate an Appliance Demanufacturing facility at the described location in conformance with Iowa Code section 455B, and Iowa Administrative Code (IAC) 567 [chapter 118](#), the rules pursuant thereto existing at the time of issuance, and any subsequent new rules which may be duly adopted, and any provisions contained in Section X of this permit.
2. No legal or financial responsibility arising from the construction or operation of the approved project shall attach to the State of Iowa or the DNR due to the issuance of this permit.
3. If title to this project is transferred, the new owner must apply to the DNR for a transfer of this permit within thirty days of the date of title transfer. The new owner must provide financial assurance, proof of training and any further information as required. This permit is void sixty days after the date of title transfer unless the DNR has transferred the permit.
4. Failure to comply with Iowa Code section 455B, or any rule of order promulgated pursuant thereto, or any or all provisions of this permit may result in: 1) a civil penalty of up to \$5,000 for each day of violation, pursuant to Iowa Code section 455B.307, or 2) the suspension or revocation of this permit, pursuant to Iowa Code section 455B.305.
5. The issuance of this permit in no way relieves the applicant of the responsibility for complying with all other local, state, and federal statutes, ordinances, and rules or other requirements applicable to the establishment and operation of this appliance demanufacturing facility.

X. Special Provisions - None

1. The project shall be operated in accordance with IAC 567-118 and the approved site operation plan dated April 3, 2023 ([Doc# 106275](#)) Updated plans shall be submitted at the time of each permit renewal and included with any request for permit modification or significant changes in facility operation.
2. An annual report is due January 31 each year for the activities of the previous calendar year, with the information required in subrule 118.13(2). The report is to be submitted on forms provided by the department, and be retained by the permit holder for at least three years.
3. The permitted appliance demanufacturing facility shall retain the records on site in accordance with in accordance with Iowa Administrative Code (IAC) 567 Chapter 118.13(3) (455B, 455D).
4. The permit holder shall provide continuous financial assurance coverage for site closure in accordance with 567—118.16(455B, 455D). The permit holder shall submit proof of

compliance, with each permit renewal, until released from this requirement by the DNR. The current cost closure estimate is for \$1915 ([Doc# 106275](#)) provided by Matthew D. Corry. The financial assurance mechanism is a \$1,950 Letter of Credit from West Bend Insurance Company ([Doc# 106275](#)).

5. The PCB ID issued by the EPA for this facility is IATSCA113790 ([Doc#114811](#)).
