This is a reminder that pursuant to rule 567—122.11(455D), the annual facility activity report (DNR Form 542-8131) is **due to the Iowa Department of Natural Resources (DNR) by February 1**, for the previous calendar year.

Submitting a complete report fulfills the annual registration renewal requirement. Once a complete report (addressing all of the reporting requirements) is received and confirmed complete in writing by the DNR, the facility's registration will be renewed until March 1 of the following year. Failure to submit the required reporting will result in registration expiration on March 1, 2026.

567—122.11(455D) Reporting requirements. CRT collection facilities and CRT recycling facilities shall report the following information on Form 542-8131, provided by the department, to the department by February 1 of each year for the previous calendar year.

122.11(4) Indication of whether the CRTs received over the past year were generated by households, businesses, or both households and businesses.
