RE: Marshall County Sanitary Landfill - "Area A" (CLOSED)  
Permit No. 64-SDP-06-92C  
Unnumbered Amendment

Dear Mr. Robertson:

The Iowa Code requires that all disposal project permit holders comply with the following provisions that have not been specifically addressed in your permit:

- Iowa Code paragraph 455B.306(6)"d"  
Requiring the submission of an Emergency Response and Remedial Action Plan.
- Iowa Code subsections 455D.9(1) and (6)  
Prohibiting the burial or burning of yard waste at a sanitary disposal project.

In order to facilitate the inclusion of these requirements as part of your current permit, the following are hereby incorporated as provisions of your permit as an unnumbered amendment, effective the date of this letter.

**Add the following Special Provision to the permit:**

*The permit holder shall submit an Emergency Response and Remedial Action Plan that addresses in detail the following requirements in compliance with Iowa Code paragraph 455B.306(6)"d":*

- Established provisions to minimize the possibility of fire or explosion.*
- Established provisions to minimize any releases to air, land or water of pollutants that could threaten human health and the environment.*
- The identification of possible occurrences that may endanger human health and environment.*

*The permit holder is required to submit the Emergency Response and Remedial Action Plan to the Department by May 1, 2001.*

**Insert the following Yard Waste General Provision in the permit:**

*The permit holder is prohibited from burying or burning yard waste as stipulated under 567 IAC 105.1(2) and Iowa Code subsections 455D.9(1) and (6). Yard waste is defined in 567 IAC 100.2(455B,455D) as grass clippings, leaves, garden waste, brush and trees. Yard waste does not include tree stumps. This prohibition supersedes any previous conflicting permit provisions.*


**Replace the Annual Water Quality Report Special Provision of the permit with the following:**

*An Annual Water Quality Report (AWQR) summarizing the effects the facility is having on groundwater and surface water quality shall be submitted to the Department's Main and local Field offices by November 30 (or by date previously authorized) each year. This report shall be prepared in accordance with 567 IAC 103.2(8) "d" [or 567 IAC 103.7(4) "e" for CCR facilities] by a Professional Engineer licensed in the State of Iowa. The AWQR shall include the results of the monthly (or the frequency previously authorized) groundwater measurements conducted at the monitoring points.*

This amendment must be kept with the permit and the approved plans at the sanitary disposal project in accordance with 567 IAC 103.2(2) "c". Please review this amendment with your operators, as they must become familiar with it.
